is Concluded by and betwixt both parties that George Wood Shall have in full Satisfaction of the Said Non performance of his Lease and Sale of fifteen acres all that house orchard home Lot Land in the field Meadow at South With all Rights members and appurtenances belonging to the accommodation Which the Said John Scott bought of James Moiles formerly John Gosbies all which the Said George Wood his heirs and assigns Shall Enjoy forever to the performance of the premises the Said John Scott and John Wood do put to their hands this 15th of June 1665

Whereas I the within named James Moiles did Impower Capt. John Scott of Seatocitt on Long Island to Dispose in my behalf of a house Land and other appurtenances and accomondations thereto belonging Which formerly I purchased of John Gosbe Deceased Situated and being in huntington and the bounds and Limits thereto belonging: and Whereas the said John Scott hath Disposed to George Wood the Said house Land and other appurtenances as by this deed Within Written may more at Large appear and Whereas James Chichester of the Said Town pretended

I the Said Moiles am Indebted to him hath Unjestly molested the Said George Wood in the quiet possession of the Said house and Land these therefore WITNESS that I the Said Moiles doth avouch and affirm that the Said Chichester is about Twenty pounds Sterling in my debt the Which I Shall Sufficiently prove in time and place Convenant and I do hereby Ratifie and Confirm and allow of this written deed made by Captain Scott for my Use and behoof to George Wood his heirs and assigns forever Disowning for myself my heirs and assigns all right title Claim or Interest in or to the Said house and Land and I do hereby Impower Theophilus Philips of New Town on Long Island to be my Attorney to Acknoledge this Deed in Court and to have it recorded as Witness my hand and Seal the 30th December 1670 Witness
